

BOUNDARY SURVEY

IN THE NORTH 1/2 OF SECTION 36 TOWNSHIP 6 SOUTH, RANGE 16 EAST COLUMBIA COUNTY, FLORIDA

NOTES:

- 1.) Monumentation is as shown and designated on the face of the plat.
- 2.) Boundary based on monumentation found in place, Instruction by client, prior surveys by W.C. Hale, B.G. Moore, L.S. Britt.
- 3.) Bearings projected from R/W of County Rd. 18 and based on Florida Department of Transportation R/W maps
- 4.) Interior improvements, if present, are not located with this survey.
- 5.) Underground encroachments, if present, were not located with this survey.
- 6.) This survey was made without benefit of a title search. There may be additional easements, restrictions, etc. not shown hereon but found in the Public Records. Issues regarding title, land use & zoning, easements & other encumberances are not a part of the scope of a Boundary Survey and can only be revealed with a title search.
- 7.) Date of field survey completion: June 15, 2016.
- 8.) Examination of the Flood Insurance Rate Maps (FIRM) for Columbia County shows that, per said maps, the described parcel lies partly in Flood Zone "X" (outside 0.2% annual chance flood plane, aka 500 year flood) and partly in Flood Zone "A" (1% annual chance flood plain, aka 100 year flood). 




